THE FUNDING GAP

Charter schools do not receive the same type of funding as independent school districts.

An independent school district receives funding from local property taxes, local bonds, voter-approved budget overrides, and facilities funding from the state's school facilities board.

A charter school's funding only comes from the state's general fund and some federal grants.

At the end of the day, independent school districts receive significantly more in public funding than nonprofit charter schools. Depending on the district a charter school can receive anywhere from **\$1,500-\$2,400 less per student** than the public school next door.
